that is as true for civilians as it is for law enforcement. Magazines eventually wear out and firearms become useless without them.

- 6. The Federal Way Police Department has continued using, since the filing of this lawsuit, Federal Way Discount Guns' range facilities.
- If any Community Partner of Federal Way Police Department was engaged in activity the
  Department believes was actually illegal, and not Constitutionally protected, they would be
  investigated.
- 8. The Attorney General's overly aggressive attempt to, apparently, financially cripple Federal Way Discount Guns, given their relationship with the Federal Way Police Department would do more harm to this community than any reduction in the number of so-called "large" capacity magazines.
- 9. From a public safety perspective, there is no irreparable injury that has been or will be caused by Federal Way Discount Guns continuing its business unaltered the only risk of irreparable harm here is that the Federal Way Police Department faces the loss of a valuable partner who helps us train, outfits us with arms, and actively helps to combat gun violence in this community.
